MINUTES OF THE MEETING OF ADVISROY COMMITTEE HELD ON 12-05-2017 IN CGHS WELLNESS CENTRE NO-1, SECTOR 45, CHANDIGARH

The meeting of the CGHS advisory Committee was held at 09.30 a.m. on 12 May, ,2017 and was presided over by Dr Ashwani Kumar Seniaray, Senior CMO (SAG), I/C CGHS Wellness Center, Sector 45, Chandigarh, and attended by the following members:

Welcome Address:

Dr. Ashwani Kumar Seniaray, Senior CMO (SAG) In-charge CGHS Wellness Center No 1, welcomed the members of the Advisory Committee. Sh Didar Singh intimated that they had sought a meeting with Smt kirron Kher a few days earlier to request her to expedite the allotment of plot of land to the CGHS and waited for almost 3 to 4 hours till late in the evening, but due to other commitments, the Hon'ble M P could not spare time to meet them. CMO appreciated the efforts being made by the members in this direction, and requested them to continue their efforts, so that the plot of land in Sector 41 for the establishment of CGHS set-up is handed over to the CGHS at the earliest.

MRC status/Pendency of claims:

As per the information from Addl Director CGHS Office, Chandigarh, the Medical Reimbursement Claims (MRC) Bills of the CGHS pensioner beneficiaries have been scrutinized and approved up to Feb,2017, but MRC payments have been made up to Oct,2016 only. CMO contended that maximum available funds were utilized to clear the pending bills of HCOs, so that pensioner CGHS beneficiaries continue to get hassle free cashless services in the empanelled hospitals/ diagnostic Centers etc. He also intimated that CCL, Chandigarh has started providing cashless services to CGHS beneficiaries as their pending bills have been cleared.

Performance of Local Chemist:

Shri Vinit Goel, representative of the authorized chemist, was advised to continue to ensure timely and correct supply of LP medicines and drugs to avoid inconvenience to CGHS beneficiaries.

Availability of Drugs in the WC:

As per records, there are 24 Generic items and 220 Proprietary items available in the WC. Fresh supply of medicines / drugs is expected shortly to enhance the stock of available medicines in the Wellness Center.

Amenities for the beneficiaries:

The wellness centre is functioning to its maximum capacity, giving cover to more than 28,000 CGHS beneficiaries on its rolls. It is also catering for such CGHS beneficiaries visiting the city from outside. During peak hours the Wellness Center is over crowded

Staff Punctuality & Behavior:

The conduct and behavior of the staff of the Wellness Center has been good. They are courteous and helpful to the senior/aged CGHS beneficiaries.

Cleanliness & Maintenance of Wellness Centre:

The Wellness Center is holding huge quantity of medicines and drug in its limited space, which makes it congested. However, in the prevailing circumstances, its upkeep is appreciable.

Suggestion / Grievance Redressal:

- (a). The CMO intimated that all formalities to accord approval for empanelment of Grecian Super specialty Hospital, Sector 69, Mohali, have been completed, and formal orders for its empanelment are likely be issued soon. In all probability, its empanelment will be w e f 15 May, 2017.
- (b) In response to point raised by Shri D D Sharma, representative of serving CGHS beneficiaries, the CMO I/C intimated that CGHS is not providing regular services for children immunization programme, as it is being conducted on the national/ state level by the Health Depts. More-over, a cold-chain refrigeration is required for storing some vaccines to maintain their potency, which is not available in the Wellness Center.
- (c) It was again stressed by the members to explore the possibility of empanelling more diagnostic Centers / Laboratories for the benefit of CGHS pensioner beneficiaries.

Suggestion Box was opened by Shri Didar Singh, and found to be empty.
