# MINUTES OF THE MEETING OF ADVISROY COMMITTEE HELD ON 23-06-2017 IN CGHS WELLNESS CENTRE NO-1, SECTOR 45, CHANDIGARH

The meeting of the CGHS advisory Committee was held at 09.30 a.m. on 23 June, ,2017 and was presided over by Dr Ashwani Kumar Seniaray, Senior CMO (SAG), I/C CGHS Wellness Center, Sector 45, Chandigarh, and attended by the following members:

#### **Welcome Address:**

Dr. Ashwani Kumar Seniaray, Senior CMO (SAG) In-charge CGHS Wellness Center No 1, welcomed the members of the Advisory Committee. The committee members were apprised that the Chandigarh Clinical Labs, empanelled for conducting various blood tests etc is again declining the cashless facility to the CGHS Pensioner beneficiaries. To forestall any such arms twisting by the CCL, there is need to finding other NABL approved diagnostic laboratories for empanelment under CGHS for the hassle free diagnostic services to the CGHS beneficiaries. He intimated that SRL Diagnostic Center (Laboratory at SCO 24, Sector 11D, Chandigarh) and Atuliya Healthcare (SCO 112-113 Madhya Marg, Sector 8C, Chandigarh) had shown interest in this direction. Shri Didar Singh, and the Chairman, CCCGPA, Shri M L Panghotra, are following up the case actively for their early empanelment.

The CMO also intimated that Grecian Hospital, Sector 69, Mohali (Phone: 0172-4696600) has since been empanelled under CGHS, Chandigarh. Possibility of extending its diagnostic lab for CGHS OPD services is also being probed.

The committee members also expressed their concern about the early allotment of the earmarked plot of land in Sector 41 for the CGHS setup. Shri Didar Singh intimated that they are following it up vigorously.

## MRC status/Pendency of claims:

As per the information from Addl Director CGHS Office, Chandigarh, the Medical Reimbursement Claims (MRC) Bills of the CGHS pensioner beneficiaries have been scrutinized and approved up to March,2017, and the payment / clearance of MRC will be done shortly after receipt of budget for the next quarter.

#### **Performance of Local Chemist:**

There has been no problem with the supply of local purchased medicines from the local chemist. The supply of indented medicine is being received in time.

### **Availability of Drugs in the WC:**

As per records, there are 26 Generic items and 264 Proprietary items available in the WC. No problem is being faced by any CGHS beneficiary in supply of medicines.

#### Amenities for the beneficiaries:

The wellness centre is functioning to its maximum capacity, giving cover to more than 28,000 CGHS beneficiaries on its rolls. It is also catering for such CGHS beneficiaries visiting the city from outside. During peak hours the Wellness Center is over crowded

#### **Staff Punctuality & Behavior:**

The conduct and behavior of the staff of the Wellness Center has been good. They are courteous and helpful to the senior/aged CGHS beneficiaries.

#### **Cleanliness & Maintenance of Wellness Centre:**

The Wellness Center is holding huge quantity of medicines and drug in its limited space, which makes it congested. However, in the prevailing circumstances, its upkeep is appreciable.

# **Suggestion / Grievance Redressal:**

While discussing the complaint of one of the CGHS beneficiaries, whose mother had been denied admission in one of the empanelled private hospitals on the pretext of non availability of bed, it was suggested by Shri Didar Singh that case may be taken up with the empanelled private hospitals to display the status of vacant beds at suitable places for an authentic understandings by the patients / their kin, and to avoid any heartburns / misunderstandings.

It was also stressed that strict action be taken against CCL, for violating the MOA and for putting the aged CGHS pensioner beneficiaries under undue mental strain in denying the cashless treatment to them.

Suggestion Box was opened by Shri Didar Singh, and found to be empty.
