MINUTES OF THE MEETING OF ADVISROY COMMITTEE HELD ON 10-11-2017 IN CGHS WELLNESS CENTRE NO-1, SECTOR 45, CHANDIGARH

The meeting of the CGHS Advisory Committee was held at 09.30 a.m. on 10 November ,2017 and was presided over by Dr Ashwani Kumar Seniaray, Senior CMO (SAG), I/C CGHS Wellness Center, Sector 45, Chandigarh, and attended by the following members:

Welcome Address:

Dr. Ashwani Kumar Seniaray, Senior CMO (SAG) In-charge CGHS Wellness Center No 1, while welcoming the members of the Advisory Committee, intimated the latest instructions issued by the Ministry of H&FW vide their OM No Z 15025/105/2017/DIR/CGHS/EHS dated 09 Nov, 2017, simplifying the procedure for treatment at private hospitals empanelled under CGHS/CS(MA) Rules 1944. As per this circular, CGHS beneficiaries have been allowed to undergo treatment at private hospitals empanelled under CGHS, of specific treatment procedures listed under CGHS rate list on the advice by a specialist of a Central Govt / State Govt, specialist hospital or CGHS Medical Officer without requirement of any other referral/permission letter. The empanelled hospitals shall render treatment on cashless basis in respect of pensioners, freedom fighters, regular employees etc. This is a great step forward towards extending hassle-free treatment to the CGHS beneficiaries. It may, however, be ensured that the specific clinical advice/prescription is issued by a govt specialist of the particular nature of ailment. The CGHS Medical Officer /Govt specialist shall not refer the beneficiary to any particular empanelled hospital by name, but, shall specify the treatment procedure and mention 'referred to any CGHS empanelled centre'.

In continuation of the discussion regarding empanelment of more HCOs under CGHS at Chandigarh, CMO, intimated that, FOUR additional HCOs have been empanelled under CGHS, Chandigarh. These include (1) HELIX Pathlabs, SCF 82(FF), Phase 5, Mohali, (2) Landmark Hospital, Sector 33, Chandigarh, (3) Mayo Healthcare super Specialty Hospital, Sector 69, Mohali, and (4) Health Map Diagnostic Pvt Ltd, Panchkula. Latest list of empanelled HCOs has been displayed at the Wellness Centre, Sector 45, Chandigarh.

MRC status/Pendency of claims:

As per the information from Addl Director CGHS Office, Chandigarh, the Medical Reimbursement Claim (MRC) Bills of the CGHS pensioner beneficiaries have been cleared and approved for payment up to May,2017, and the cases for June and July,17 are under process. The payments are likely to be released shortly.

Performance of Local Chemist:

There has been no problem with the supply of local purchased medicines from the local chemist. The supply of indented medicine is being received in time.

Availability of Drugs in the WC:

As per records, there are 23 Generic items and 238 Proprietary items available in the WC. No problem is being faced by CGHS beneficiaries in supply of medicines.

Amenities for the beneficiaries:

The Wellness Centre is functioning to its maximum capacity, giving cover to more than 28,000 CGHS beneficiaries on its rolls. It is also catering for such CGHS beneficiaries visiting the city from outside. During peak hours the Wellness Center is over crowded

Staff Punctuality & Behavior:

The conduct and behavior of the staff of the Wellness Center has been good. They are courteous and helpful to the senior/aged CGHS beneficiaries.

Cleanliness & Maintenance of Wellness Centre:

The Wellness Center is holding huge quantity of medicines and drug in its limited space, which makes it congested. However, in the prevailing circumstances, its upkeep is appreciable.

Suggestion / Grievance Redressal:

Suggestion Box was opened by Shri Didar Singh, and found to be empty.

Regarding the defective ceiling fan, the CMO informed that the fan has been sent for repairs, and action is being taken to plug the leakage from the roof to prevent any future damage.
